The candidates who appeared in the State Eligibility Test (SET) held on 29th May, 2016 should note that the Answer Keys & the Online Feedback Form are uploaded on the University website <http://setexam.unipune.ac.in> on 8/7/2016 and will be available up to 14/7/2016. The students who are not satisfied with the answer in the answer keys displayed, may give their feedback/challenge answers in the prescribed Online feedback form.

The candidates should note the following things before filing the online feedback form.

1. First ensure the questions for which feedback is to be given.
2. Accordingly, draw a Demand Draft of appropriate amount (@Rs.1000/- per question) on any Branch of **Bank of Maharashtra or HDFC Bank** in favor of "**Finance & Accounts Officer, Savitribai Phule Pune University, Pune**" payable at Pune.
3. Each Candidate can submit Online Feedback Form only once.
4. Fill in the required information in the online feedback form. (Preview the form to ensure correctness)
5. After successful submission of the form through online mode, take printout of the same.
6. The printout of the feedback form along with Demand Draft, Xerox copies of documentary evidences, if any, should reach to "The Co-ordinator(SET), SET Bhavan, Savitribai Phule Pune University, Pune-411007 on or before 20th July, 2016.
7. No challenges will be accepted without online feedback form submission. In case, the feedback is accepted, the fee corresponding to the number of answers /challenges accepted will be refunded to the candidates. In all other cases the fee once paid will not be refunded.
8. The incomplete applications, applications without Demand Draft, receipt of form after deadline will not be entertained.
9. The challenges will be evaluated by the experts and the answer keys will be finalised as per U.G.C. guidelines and uploaded on the University website.
10. The State Agency's decision on the student's feedback shall be final and the result will be prepared on the basis of final answer keys.
11. The candidates should take a printout of the RTGS form (available online) fill in the details & submit it along with the printout of the feedback form. No refund will be made without submission of the RTGS form.
