Valid request(s) in all respects will be placed before the Expert Committee(s) for re-examination of the answer key(s). In case the answer(s) is/are found to be incorrect, SET will process the result in light of changed key(s) and qualify the additional candidates without changing the result of candidates qualified provisionally as per this notification.
5. Grievances received without supporting documents/literature are liable to be rejected.
6. No grievances pertaining to answer key(s) of SET for examinations conducted prior to 29th May, 2016 will be entertained.
7. In the event of any information being found false or incorrect in the Application Form/ OMR sheet or detection of any ineligibility, the candidate is liable to be disqualified even after declaration of this result.
8. SET takes utmost care in finalization of result. However, if any error is detected at a later stage, SET may rectify the result accordingly.
